Description A set of functions to allow analysis of count data (such as faecal egg count data) using Bayesian MCMC methods. Returns information on the possible values for mean count, coefficient of variation and zero inflation (true prevalence) present in the data. A complete faecal egg count reduction test (FECRT) model is implemented, which returns inference on the true efficacy of the drug from the pre and post treatment data provided, using non-parametric bootstrapping as well as using Bayesian MCMC. Functions to perform power analyses for faecal egg counts (including FECRT) are also provided. Requires Just Another Gibbs Sampler (JAGS) for most functions (except power analysis calculations), see: <http://www-fis.iarc.fr/~martyr/software/jags/>.

Description

Apply a Bayesian [zero-inflated] gamma / Weibull / lognormal / independant / simple Poisson model to count data to return possible values for mean count, coefficient of variation, and zero-inflation. A text .csv file named [name].[model].csv with the results is optionally written to the working directory (before checking if the file already exists), and an object [name].[model].results is copied to the Global environment within R. Where more than 1 model is used, a results file and object is created for each model. Convergence is assessed for each dataset by calculating the Gelman-Rubin statistic for each parameter, see [autorun.jags](#). Optionally, the log likelihood for the model fit is also calculated. The time taken to complete each analysis (not including calculation of the likelihood) is also recorded. This function is a wrapper for bayescount.single(), allowing extra automation. The lower level functions in the runjags package are used for calling JAGS.

Note: The GUI interface for R in Windows may not continually refresh the output window, making it difficult to track the progress of the simulation (if silent.jags is FALSE). To avoid this, you can run the function from the terminal version of R (located in the Program Files/R/bin/ folder).

Arguments

name	a name for the analysis (character). Missing by default (function will require it to be input).
data	either a path to a comma delimited csv file, or an existing R object containing the data. Data can be specified in one of the following ways. If a numeric vector, or as a matrix or array with 1 column only, the data are taken to be a single dataset. If a matrix, then each column of data is taken to be a dataset. If an array, then each element of the 3rd dimension represents a dataset, and each column represents repeated McMasters counts from the same sample (each row). A list containing the elements 'totals' representing the sum of the repeated McMasters counts, and 'repeats' representing the number of McMasters counts performed per sample, is also supported (these may be matrices, in which case each column is a separate dataset). If the data is in a comma delimited file, it must be in the format specified for a single matrix. Missing data, or unused elements of non-ragged arrays, may be represented using NA, which will be removed from the data before analysis. This argument is 'NA' by default (function will require a path to the data to be input).
setnames	either a character vector of names for each dataset, a logical value indicating if the data contains column labels in the first row, or an NA. If a character vector, the function will quit if the length does not match the length of the data. If TRUE, the dimnames[[2]] attribute of the matrix will be used if present, and failing that the first row of data is used. If NA, then the function will use the dimnames[[2]] attribute of the matrix as setnames if it is not NULL, or otherwise generate them. If FALSE, generic names are used. If data is specified as an array or list, setnames must be provided as a character vector or left as FALSE (or NA). Default NA.
model	vector of models to use. Choices are "GP" (gamma Poisson = negative binomial), "ZIGP" (zero-inflated gamma Poisson = zero-inflated negative binomial), "LP" (lognormal Poisson), "ZILP" (zero-inflated lognormal Poisson), "WP" (Weibull Poisson), "ZIWP" (zero-inflated Weibull Poisson), "SP" (simple Poisson), "ZISP" (zero-inflated simple Poisson) or "IP" (independent Poisson), or "all" for all of these models (case insensitive). The simple Poisson model forces each count to have the same mean, whereas the independent Poisson process allows each count to have an unrelated mean (therefore a zero-inflated version is not possible). divide.data	count division factor to allow egg count data in eggs per gram to be used raw (numeric). Default 1 (no transformation to data).
scale.mean	count multiplication factor to allow results to be reported as eggs per gram. Default equal to divide.data, so that results are reported with the same mean as the input data.
remove.all.zeros	remove any datasets where the total number of counts is 0, since it is not appropriate to use a count model to analyse these data (logical). Some models may crash repeatedly when trying to analyse a dataset with no observations. Default TRUE.
test	should the function briefly test the model with the first column of data before running the simulation? (logical) Affords extra 'user-proofing'. If set to FALSE

and valid values are supplied for 'name', 'data' and 'setnames', the function will not require input at any point (useful for automated data analysis). Default TRUE.

alt.prior	should the model run the [ZI] [WPIGPILP] models using the standard or the alternative prior distribution for variability? (logical) Can also be a character value of a user-specified prior distribution. Default FALSE. Where information concerning the coefficient of variation in the data is sparse, the choice of prior distribution will have an affect on the posterior distribution for ALL parameters. It is recommended to run a simulation using both types of prior when working with small datasets, to make sure results are consistent.
write.file	should the function write a text file to the current directory containing the results? (logical) Default TRUE. If FALSE, the text file is written during analysis and then deleted on completion of the dataset.
adjust.zi.mean	should the mean count parameter of the zero-inflated models be adjusted to reflect the mean of the whole population? (logical) If FALSE the mean count of the zero-inflated models reflects the mean of the gamma or Poisson distribution only, if TRUE the mean includes extra zeros. Used for comparing results between zero-inflated and non zero-inflated models. Default FALSE.
likelihood	should the (log) likelihood for the fit of each model to each dataset be calculated? (logical) The likelihood for the [ZI] LP and GP models are calculated using a likelihood function integrated over all possible values for lambda, which can take some time. The likelihood is calculated using a thinned chain of 1000 values to reduce the time taken. Likelihood calculations for the [ZI] WP model are currently not available for data with repeated observations, or for any model with either missing data or different numbers of repeated observations per sample within a dataset. Default FALSE.
record.chains	should the final mcmc chains generated for each simulation be saved to disk for future analysis? If TRUE, an Rsave binary file is saved in the current working directory with a filename made up of the name of the analysis, model and dataset name. The function <code>new_unique</code> is used to generate the filename to ensure that no files are ever over-written. Default FALSE.
...	further arguments to be passed directly to <code>autorun.jags</code> , including the path to JAGS, number of burnin and sampled iterations, target PSRF, time limit to extend each simulation, etc. Note that some of the default arguments to <code>autorun.jags</code> are changed by <code>bayescount.single</code> (<code>max.time="1hr"</code> , <code>interactive=FALSE</code> , <code>plots=FALSE</code>), but these can be over-ridden.

Value

No value is returned by this function. Instead, a text .csv file named `*name*.*model*.csv` with the results is optionally written to the working directory (before checking if the file already exists), and an object `*name*.*model*.results` is copied to the Global environment within R (this will over-write any existing object of the same name). Where more than 1 model is used, a results file and object is created for each model.

The results files consist of a table (or matrix) with the following results for each dataset:

name	the name of the dataset. This is a dimnames attribute for matrices.
------	---

converged	a logical flag indicating a PSRF of below the target indicating successful convergence (1), or the opposite (0). Datasets where the model initially converged but the subsequent final chains had a PSRF of more than the target are classified as 'converged', but a warning message is printed in the function and the datasets will have an error code of 4.
error.code	a numeric code indicating the exit status of the simulation. 0 indicates no errors encountered, 1 indicates a repeatedly crashing model, 2 indicates a failure to converge within the specified time limit, 3 indicates a dataset with no observations that was removed from analysis, 4 indicates a model that initially converged but the subsequent final chains had a PSRF of more than the target, and 5 indicates an unknown error in the function not related to the model (i.e. a bug in the runjags/bayescount code...).
samples	the number of sampled iterations calculated by raftery.diag to reduce the MC error to the specified level.
samples.to.conv	the number of sampled iterations discarded as a result of slow convergence (will be 0 if the pilot chain converged).
parameter estimates	the lower 95% credible interval, median estimate and upper 95% credible interval for the mean, coefficient of variation, zero-inflation, log mean, log variance, shape parameter, and scale parameter as appropriate to the model.
multivariate.psrfr	the multivariate PSRF of the final mcmc chains. If this couldn't be calculated, NA.
likelihood estimates	the lower 95% credible interval, median estimate, upper 95% credible interval and maximum observed value (this is NOT equivalent to the maximum likelihood) of the likelihood for the model. For the compound distributions these likelihoods are integrated for all possible values of the Poisson means (calculated using likelihood), and may well be different to the deviance calculated using JAGS.
time.taken	the total time in seconds taken to run the simulation (not including calculating the likelihood and other summary statistics).

The time taken to complete each analysis (not including calculation of the likelihood) is also recorded. The lower level functions in the runjags package are used for calling JAGS.

data	an existing R object containing the data. Data can either be specified as a numeric vector of single counts for each sample, or as a matrix of repeated counts (columns) for each sample (rows). Repeated counts are modelled as part of the same Poisson process. Data can also be specified as a (ragged) list of repeated counts, with each element of the list representing a separate sample. Finally, data can be specified as a list containing the elements 'totals' representing the sum of the repeated McMasters counts, and 'repeats' representing the number of McMasters counts performed per sample. Value

Either a vector similar to that obtained from [bayescount](#) containing an indication of the error/crash/convergence status, the number of sampled updates used, and a lower/upper 95% highest posterior density interval (see [HPDinterval](#)), and median estimate for each relevant parameter (optionally including the likelihood), or an MCMC object representing the estimates at each iteration for both chains (optionally including the likelihood).

FEC Power Analysis Calculations

Description

Finds the power for a faecal egg count study with the given combination of parameters. This represents the probability that the observed empirical mean FEC will lie between the lower.limit and upper.limit specified. The power is calculated using the negative binomial distribution when considering the true mean of a single individual, or using Monte Carlo integration for more than one animal. Confidence intervals for the true power are produced for the latter.

meanepg	the mean egg count of the group (in EPG). If this is unknown then use a value likely to be encountered, or iterate over a distribution of values to obtain a distribution of values for power.
g.faeces	the number of grams of faeces used per sample (must be the same for all samples).
sensitivity	the minimum egg detection threshold or counting sensitivity of the technique used. If using the McMasters technique, this is the number of McMasters chambers counted divided by 50.
replicates	the number of different samples (individually analysed) taken from each animal. Must be the same for all animals. This would normally be 1, but increasing this provides an effective way of improving power at the cost of additional laboratory work.

accuracy	specify the lower and upper limits as the meanepg +/- this fraction of the meanepg. Ignored if non-default values are specified for lower.limit or upper.limit.
lower.limit	lower limit for the tolerance. Specifying lower.limit and upper.limit separately allows non-symmetrical tolerance around the mean with which to calculate the power. The default is to use meanepg*(1-accuracy).
upper.limit	upper limit for the tolerance. Specifying lower.limit and upper.limit separately allows non-symmetrical tolerance around the mean with which to calculate the power. The default is to use meanepg*(1+accuracy).
maxiterations	the maximum number of iterations to use for the Monte Carlo integration, or the number to use if precision=NA. If precision is defined, then only the number of iterations required to estimate the power to the given precision are performed (up to a maximum of maxiterations).
precision	the number of decimal places with which to calculate the power, unless maxiterations is reached first. A larger precision will give a more precise estimate of the true power but will take longer to calculate. Specifying this as NA performs the calculation on a fixed (=maxiterations) number of iterations.
confidence	the degree of confidence required with which to report confidence limits for the true power when using Monte Carlo integration to report the power.
feedback	option to display a progress indicator for calculation of the values used for Monte Carlo integration. Using feedback with some GUI versions of R may slow down the analysis considerably.
forcesim	option to force the function to use the Monte Carlo method of approximating the power when the default would be to use a negative binomial approximation (when true.sample=FALSE and coeffvargroup is very small, or when true.sample=TRUE and animals=1). Results using the two methods should be very similar, however there may be differences due to the different optimisation mechanisms when calculating both lower and upper limits. In addition, Monte Carlo integration will take longer and gives a confidence interval for the true mean rather than the absolute value.

Value

Returns a list containing the elements 'roundedci' and 'ci', which specifies the median and confidence limits (as defined by 'confidence') for the true power both rounded by 'precision' and unrounded. For analyses using the Monte Carlo integration method, 'within' 'without' and 'total' are also returned, and indicate the number of iterations for which the observed mean fell outside and inside the specified limits and the total number of iterations.

fec.power.limits *FEC Power Analysis Calculations (find tolerance)*

Description

Finds the appropriate tolerance with which to consider the observed mean for a faecal egg count study with the given combination of power and other parameters. The power is calculated using the negative binomial distribution when considering the true mean of a single individual, or using Monte Carlo integration for more than one animal. Confidence intervals for the true power are produced for the latter. Tolerance can be defined as either a lower limit only if upper.limit is defined, as an upper limit only if lower.limit is defined, or as both (equidistant) limits if neither are defined.

<code>iterations</code>	the number of iterations to use for the Monte Carlo integration. More iterations will take longer but provide a smaller confidence interval for the true power.
<code>power</code>	the desired power with which to interpret the given tolerances. Default is 0.95, so that the observed mean FEC will lie within the calculated lower and upper limits 95% of the time.

Analyse FECRT Data Using Mcmc to Give a Probability Distribution of Values for the Mean Egg Count Reduction

Description

This function applies a Bayesian [zero-inflated] gamma Poisson (negative binomial) model to faecal egg count reduction test (FECRT) data to return possible values for the mean drug efficacy. Pre-treatment data are assumed to arise from either a gamma-Poisson or zero-inflated gamma-Poisson distribution, with post-treatment data described by a separate gamma-Poisson or zero-inflated gamma-Poisson distribution. The change in mean between these distributions is therefore the mean egg count reduction. If `paired.model=TRUE`, a slightly different formulation is used whereby the observed count pre-treatment is assumed to follow a compound gamma-gamma-Poisson distribution with the variability within and between animals separated. The post treatment mean for each animal is derived from the pre-treatment animal mean and FEC reduction. This formulation allows data with non-random missing post-treatment counts to be analysed correctly, and also allows data with repeat counts from an individual to be analysed - providing a method of increasing the power of the method substantially. Results are also obtained using non-parametric bootstrapping and the method advocated in the 1992 World Association for the Advancement of Veterinary Parasitology (W.A.A.V.P.) methods for the detection of anthelmintic resistance in nematodes of veterinary importance (unless the data contains repeat values or missing values). Confidence intervals for the relevant statistics are printed to file if `write.file = TRUE`, and returned using a custom print method.

Lower level running of JAGS and assessing the simulation for convergence and required run length is done using `autorun.jags`. Note: The GUI interface for R in Windows may not continually refresh the output window, making it difficult to track the progress of the simulation (if `silent.jags` is `FALSE`). To avoid this, you can run the function from the terminal version of R (located in the Program Files/R/bin/ folder).

It is possible for the functions that use integrate to produce incalculable probabilities for some iterations, in which case the likelihood for these iterations are returned as missing data (and therefore the summary statistics for the whole simulation are also returned as missing data). If only 1 iteration of values for mean/variance/shape/scale are provided, a single value for likelihood is output.

Description

Crude function to maximise the likelihood of one of the following distributions: Poisson (P), gamma (G), lognormal (L), Weibull (W), gamma Poisson (GP), lognormal Poisson (LP), Weibull Poisson (WP), all with or without zero-inflation (ZI). Uses the likelihood() function to calculate the likelihood at each iteration. For mixture models, the likelihood is calculated for the data by integrating over each possible value of lambda for each data point, which may take some time for large datasets. Starting values for each parameter are optional, but may improve the speed and reliability of the function if appropriate values are provided. If missing, starting values will be calculated from the data.
